

The installation for this ventilation system is quick and easy for all types of houses.


### WHOLE-HOUSE AIR EXCHANGER

#### Control

- Also, this control is equipped with a Maintenance indicator, telling you when it is time to perform the filter maintenance

In Canada, the EA 1500 is fully protected by a 2-year warranty on all parts and labor in workshop only.


In the United States, the EA 1500 is fully protected by a 2-year warranty on all parts only.




### **Attic Installation\***

### **Basement Installation**



Only one outside connection is needed when using the Tandem® transition (**A**) and the dual outside port (**B**), simplifying the installation. (Both **A** and **B** are included in installation kit no. 15273).
